This Speeding Ticket Limited Guarantee is only applicable to Escort Max 360c/Max 360/Redline EX/Escort ix purchased directly from Escort via its toll-free number at 1-800-757-1308 or at Escort's e-commerce site at www.EscortRadar.com. Ticket reimbursement coverage is available for 1 year from the date of purchase. Ticket Reimbursement promotion expires on December 31, 2018.

This limited guarantee is only available for radar and laser detected speeding tickets and subject to the terms and conditions below.

Terms and Conditions

- 1.) To request reimbursement, you must provide Escort with all of the following - (a) a fully completed and signed copy of the **Escort Speeding Ticket Limited Guarantee Request for Reimbursement** form which is available by calling Customer Service at 800-543-1608 (b) a copy (not the original) of your speeding ticket, which must clearly identify that the ticket was received for a radar or laser detected speeding violation or provide other proof that ticket was for speeding violation detected by radar or laser; and (c) Proof of ticket payment (Either copy of both sides of cancelled check, money order or court receipt). - 2.) Reimbursement is only available for speeding violations received by the original purchaser of the eligible Escort detector and shall only apply to radar or laser detected speeding violations occurring during the first year of ownership. **(The 'Promotions Coverage Period') *Request for Reimbursement must be received within 45 days of the expiration of your coverage period.**
- 3.) The limited guarantee expressly excludes speeding tickets issued in conjunction with any one or more of the following traffic violations – reckless driving, racing, school or construction zone violations, driving while under the influence (DUI) or driving while intoxicated (DWI) or similar violations under relevant federal, state, or local laws.
- 4.) This limited guarantee does not provide reimbursement for attorney fees, late fees, increased insurance premiums or fees and penalties other than radar or laser detected speeding violations.
- 5.) This limited guarantee is only valid in the United States and is expressly NOT valid in the District of Columbia, State of Virginia, any other jurisdiction where prohibited by law, and/or other jurisdictions where radar/laser detection devices are prohibited by law.
- 6.) Applicant for reimbursement must be 18 years or older and a licensed driver. This Limited Guarantee is limited to a maximum reimbursement of US \$250 per radar or laser detected speeding ticket and to a maximum of two radar or laser detected speeding violations per ESCORT device.
- 7.) Escort will only pay your ticket if your account is in good standing.
- 8.) The Ticket Protection Guarantee is void if the eligible detector has been returned for a refund.
